The Georgia DNR Law Enforcement's Accelerated Degree Advancement Promotional Track (A.D.A.P.T.) program is an excellent opportunity for individuals interested in pursuing a career as a Georgia Game Warden. This initiative not only provides a pathway for those with a High School Diploma or GED to apply and become Game Wardens but also facilitates the acceleration of their college degree progress.

Applying and minimum requirements:

- 21 years of age
- Have a high school diploma or GED
- Be a citizen of the United States
- Be eligible to obtain a valid Georgia Driver's License at the time of appointment
- Applicants who are not POST Certified must pass the POST Entrance Exam (Accuplacer) to be considered for a Game Warden position. A copy of the test scores must be provided prior to employment. - Applicants do not specifically apply for the A.D.A.P.T. program. They apply for the position of Game Warden and, if they are hired, they will have the opportunity to work through the A.D.A.P.T. program.
- Successfully pass:
 - Physical Agility Test
 - Polygraph Exam
 - Board Interview
 - Medical Evaluation
 - Psychological Evaluation
- Successfully complete the POST Academy (Basic Mandate)
- Successfully complete the Georgia Game Warden Academy

Here are some key points to consider if you are thinking about pursuing a career as a Georgia Game Warden through the A.D.A.P.T. program:

- Education Advancement: The program offers the chance to earn college credit while attending
 the P.O.S.T. Basic Mandate and the Game Warden Academy. This credit can be applied toward
 degrees in Criminal Justice and Conservation Law Enforcement at various colleges or technical
 colleges.
- Eligibility Requirements: As the program is designed for individuals with a High School Diploma
 or GED, it provides an opportunity for a diverse range of candidates to enter the field of
 Conservation Law Enforcement.
