Our receipt of your renewal application will serve as your authorization to continue to deal or breed domestic fish after your current license expires, provided we receive a completed application by April 1, You should allow four to six weeks for your license to be issued. If you are no longer conducting a regulated activity please notify the Special Permit Unit by completing the enclosed non-renewal form to the address above.

Applicants residing **outside** Georgia must either have an **appointed agent for acceptance of service of legal process** and provide us with the agent's name and **Georgia** address, or designate the Secretary of State of Georgia for acceptance of service of legal process. If you designate the Secretary of State, no address is needed. All nonresident applications must provide this information before a license can be issued.

O.C.G.A. § 16-10-20: "A person who knowingly and willingly makes a false, fictitious, or fraudulent statement...in any matter within the jurisdiction of any department or agency of state government...shall, upon conviction thereof, be punished by a fine of not more than \$1000 or by imprisonment for not less than one or more than five years, or both."

Nonresidents must provide one of the following: (1) An address in Georgia where applicant can be personally served with legal process; (2) Appointment of an agent in Georgia (with Georgia address) for acceptance of service of legal process; (3) Designate the Secretary of State of Georgia for acceptance of service of legal process.
