Dear Georgia Sportsman,

Enclosed is the 2018-2019 Renewal Application for the deer-dog clubs. **For those that were active last year, the application procedure is the same. For those that didn't apply last year, Please note the following changes.** These changes have been implemented in order to further simplify the application process for clubs and to assist our officers to be more efficient with enforcement efforts in the field.

1. Landowners may now indicate an expiration date of their choosing. They may revoke the permission to deer-dog hunt on their property at any time by notifying DNR Special Permit Unit in writing. It will be the responsibility of the applicant to insure that this information is current and accurate when submitting application. Land Owner form must have Expiration year listed.
2. Applicants must submit an 8.5 X 11 map provided by the county tax office. The county tax office should be able to provide a map with an aerial overlay for the boundary of the properties included in the permit. Reasons for this change include a move to a computerized database and preparation for an online application option in the future. **If a map was received with your last renewal and there are no changes to the acreage a map is not required for this renewal.**
3. We realize that many clubs are still taking members up until, and after the season starts and that it is sometimes difficult to get the list in time to submit the application by the deadline. Please provide a list of **known** members when you send your application. Additions to the list may be made as members are added. Anyone not on the list must have written authorization on their person from the permittee.

Please follow the enclosed instruction page for completing your application for your Dog Hunting Permit. A check list is also included to help ensure that your application is complete.

Please send your application for renewal with **(no changes)** to DNR Special Permit Unit, 2070 Highway 278, S.E., Social Circle, GA 30025.

Those **with in acreage changes mail to your local Game Management Office along with a current map.**

In order to receive permit by the opening day of firearms deer season, completed applications must be received by the Special Permit Unit office by **September 20, 2018**

Instructions for Renewal Form for Dog Hunting Permit

Attached is the form to apply for a Renewal Dog Hunting Permit. This permit must be received by anyone desiring to hunt deer with dogs in Georgia prior to any dog hunting activity. The application is one page and requires additional information be attached in order to be complete.

Please do not combine multi Hunt clubs on same application, submit separately

Item #1. Applicants are limited to property owners and lessees, check the box that applies. If the applicant owns part of the property and leases the remainder, check both boxes. Complete all of the information for this block. Social Security number, address and date of Birth must match applicant's name.

Item #2. All tracts of land that are to be hunted must be listed to be covered under the permit. Tracts should be listed by individual property owner. **You must provide acreages and maps for all tracts.** Minimum permissible size for all leased tracts in combination is 1000 contiguous acres. However, a privately owned tract may be permitted if it is at least 250 contiguous acres. If additional space is needed, attach an additional page. **Maps should be an 8.5 X 11 official county tax map with aerial photo overlay displaying included property.** Applicant should mark access points (how will hunters get on the permitted property). Permittee will not be authorized to deer hunt with dogs on any tract not properly listed on the application or tracts for which no map or signature has been submitted. **If you submitted a map last year, you will not be required to submit a map this year (if no changes)**

NOTE: Additional properties added to a current permit will require reapplication for the permit (permittee and guests may continue to hunt on previously permitted property during review).

Each property owner or authorized agent with property to be included under the permit must print, sign and mark expiration date in the spaces provided. Any property belonging to an owner who has not signed the application will be removed from consideration. The Department will accept a notarized copy of a lease for any given parcel of land in lieu of that owner's signature, provided that the lease specifically indicates that deer hunting with dogs is authorized. **Please provide, a list of all landowners with a contact address and phone number for each parcel to be covered by this permit on the form provided**

Item #3. Please provide a list of **known** members when you submit application. Additions to the list may be made as members are added. Anyone not on the list must have written permission on his or her person from the permittee.

Signature: Application will not be processed without applicant's name and signature at bottom of application.

Permit applications must be received at least 30 days prior to the first day for hunting deer with dogs on an eligible tract. To dog-hunt deer on opening day of deer season, submit applications **no later than September 20, 2018**

If there are changes to your current acreage and or landowners please send all required materials to the correct Game Management Office for review. Check the list of offices attached to determine which office covers the county where the property is located.

If there are No Changes to your acreage or landowners please return the required materials to: **Special Permit Unit, 2070 US Highway 278 SE, Social Circle, GA 30025.**

Permittee should ensure that each landowner's name, acreage, and expiration date are listed correctly. Please provide, on attached Landowner's Authorization sheet a list of all landowners with a contact address and phone for each parcel to be covered by this permit. **Must have expiration date (mm/dd/yyyy)**

3. CLUB MEMBER/ AUTHORIZED HUNTER INFORMATION:

Please provide a list of **known** members when you submit application. Additions to the list may be made as members are added. Anyone not on the list must have written permission on his or her person from the permittee.

I hereby certify that the information in this application is complete and accurate to the best of my knowledge and belief and acknowledge submittal of false information is a violation of O.C.G.A. § 27-2-28 and will nullify any permits based on such information.
