SUBJECT: License Renewals

Enclosed please find a form for renewal of your Commercial Fox Hunting Preserve License, which will expire March 31, of this year. Please fill out the form **completely and legibly**, providing all current information; date and sign the form. Return the renewal form and any required attachments by mail. If paying by credit card, (preferred payment) please provide the necessary information on application or include a check or money order for \$80.00 by **March 1**, to:

Our receipt of your renewal application will serve as your authorization to continue to operate your fox pen after your current license expires, provided we receive a completed application by March 1, you should allow four to six weeks for your license to be issued.

Applicants residing **outside** Georgia must either have an **appointed agent for acceptance of service of legal process** and provide us with the agent's name and **Georgia** address or designate the Secretary of State of Georgia for acceptance of service of legal process. If you designate the Secretary of State, no address is needed. All nonresident applicants must provide this information before a license can be issued.

If you trap your own fox or coyote, please renew your Resident Trapping License with the License Boat Registration Unit (800-366-2661).

An annual accounting of the species and number (by species) of animals must be listed on the renewal form, as well as any change in acreage.
