Please be sure to sign and date the renewal application, enclose (Preferred payment) credit card information, or check, or money order in the amount of \$45.00 payable to the Georgia Department of Natural Resources. (DNR)

If you are no longer practicing the sport of falconry, please notify the Special Permit Unit in writing by submitting the non-renewal form or emailing Jamie.hawkins@dnr.ga.gov

All Falconry holders must complete a 3-186 A form electronically for each transfer, acquisition, release, loss, or re-banding of migratory bird held under this permit at <https://epermits.fws.gov/falCP/>. Falconers must submit forms electronically within 5-10 days of the activity. A hard copy is also to be mailed or emailed to the Special Permit Unit Falconry Administrator for your falconry state file within 5-10 days of activity. Falconry administrator email is Jamie.hawkins@dnr.ga.gov

For Falconry class upgrade requests, Apprentice to General: Submit an email to Jamie.hawkins@dnrle.gov with a request to upgrade your status. (Form is on website) This will include the dates and birds you have or had, along with an email from your sponsor indicating that said falconer has met the requirements and that they recommend the apprentice to upgrade too General. Your file and 3-186 forms will be reviewed. Be sure that you have you have practiced falconry with raptor(s) at the Apprentice Falconer level or equivalent for at least 2 years, including maintaining, training, flying, and hunting the raptor(s) for least 4 months in each year. That practice may include capture and release of falconry raptors. *Your time starts with your "effective date" which is printed on your falconry permit.*

For General to Master requests: You must have practiced falconry with your own raptor(s) at the General Falconer level for at least 5 years.

It is your responsibility to update the Special Permit Unit with any changes in contact information, change in mews location, Move to another state, or if you no longer wish to conduct falconry activities in Georgia.

Receipt of your renewal application will serve as your authorization to continue falconry activities after your current license expires, provided we receive your application and license fee by **March 1**. Your new license will be issued as soon as possible; however, you should allow four to six weeks for your license to be issued.
