Enclosed is a form for renewal of your Wild Animal License for Dealing/Breeding Regulated Fish which will expire March 31 of this year. Please fill out the form **completely and legibly**, providing all current information; date and sign the form. Return the renewal form and any required attachments, including a check, money order, or credit card information in the amount of **\$255.00**, (Fee includes the cost of the license plus a \$5 transaction fee.) by **March 1**, to:

Our receipt of your renewal application will serve as your authorization to continue to deal or breed wild animals after your current license expires, provided we receive a completed application by March 31. You should allow four to six weeks for your license to be issued.

Applicants residing **outside** Georgia must either have an **appointed agent for acceptance of service of legal process** and provide us with the agent's name and **Georgia** address, or designate the Secretary of State of Georgia for acceptance of service of legal process. If you designate the Secretary of State, no address is needed. All nonresident applications must provide this information before a license can be issued.
